1. The contractor should have the capacity to carry out, construction on fast track with quality within the defined period.
2. Bidders are required to make an offline payment for the cost of bidding document. The requisite fee shall be paid by demand draft in favour of the Project Manager, Construction & Maintenance Unit (Ganga), Uttarakhand Peyjal Nigam, Uttarkashi payable at Uttarkashi, Distt Uttarkashi, Online bids must be accompanied by the electronic scanned copy of the demand draft for the amount as mentioned in the table above for the corresponding contract package. This demand draft in original shall be submitted either by registered post or by hand in the office of Project Manager, Construction & Maintenance Unit (Ganga), Uttarakhand Peyjal Nigam, Uttarkashi on or before the date mentioned in the tender time schedule (Key Dates). Failing to do so, the bids will be declared non-responsive.
- 2- Bid Security (Earnest Money) shall be in the form of FDR / CDR or NSC issued by any Public Sector (Nationalized) / Scheduled Banks or Indian Post Offices respectively, with maturity date at least up to 45 days beyond 3 (Three) months' validity period of the Bid, pledged in favour of Project Manager, Construction & Maintenance Unit (Ganga), Uttarakhand Peyjal Nigam, Uttarkashi Online bids, to be conforming, must be accompanied by the electronic scanned copy of bid security for the amount as mentioned in the table above for the corresponding contract



The original copy of bid security shall be submitted either by registered post or by hand in the office of General Manager, Construction Circle (Ganga), Uttarakhand Peyjal Nigam, Haridwar, on or before the date mentioned in the tender time schedule (Key Dates). Failing to do so, the bids will be declared non-responsive.

- 3- Tender inviting authority reserves right to cancel the bid without assigning any reason.
- 4- It will be responsibility of bidder to upload all the required documents correctly on the website. If quoted rates of any bidder do not reflect in the system generated comparative statement due to any reason such as tempering of BOQ template, modification of BOQ template what so ever, such bid will be treated as tempered and will not be considered.
- 5- In case of holiday falling on the date of opening of tender, the tenders will be opened on the very next working day.
- 6- Tenders are invited on 2-bid system i.e. (1) Technical cum Financial capability evaluation Bid (2) Financial Bid. Technical cum Financial capability evaluation bid shall be opened at first on the date specified in key dates and financial bids of the only successful bidders who qualify for the technical-cum-financial capability evaluation bid, shall be opened and the date of which will be intimated to qualifying firm through registered post/E-mail/Fax/Telephone etc.
- 7- Amendments to this tender notice/tender document, whatsoever, will only be published on e-GPS portal <http://www.uktenders.gov.in>. bidders are advised to check the above website regularly.
- 8- Bid Submission procedure :-
  - 3.00 The bid documents shall be published online on the e-Government Procurement System (e-GPS) portal i.e. <http://www.uktenders.gov.in> on the date and time as mentioned in the tender time schedule (Key Dates).
  - 3.01 All the interested bidders are required to register on e-GPS portal i.e. <http://www.uktenders.gov.in> which is free of cost.
  - 3.02 The bidder is also required to obtain Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Digital signature is mandatory to participate in the e-tendering. More information on how to obtain a DSC and also its use is available under the link "Information about DSC" on the e-GPS portal i.e. <http://www.uktenders.gov.in> Bidders already possessing the digital signature issued from authorized CAs can use the same in these tenders.
  - 3.03 Bids shall be submitted online on the same e-GPS portal i.e. <http://www.uktenders.gov.in> after signing them electronically using a Digital Signature Certificate (DSC) within the stipulated time as mentioned in tender time schedule (Key Dates). Online bids, ready for submission / upload, shall include bidding document, scanned copy of Cost of bidding document, Bid Security, Affidavits & all the Supporting Documents in support of qualification other than rates filled by the bidder in BOQ.
- 9- Offline submission of Original Documents :- In addition to the cost of bidding document and bid security as prescribed in Sl. No. 1 & 2 above, the bidders are also required to submit in original all the documents listed in Sub Clause 4.2 of Section-III I.T.B., either by registered post or by hand, in the office of General Manager, Construction Circle (Ganga), Uttarakhand Peyjal Nigam, Haridwar, Uttarakhand upto the date and time as mentioned in tender time schedule (Key Dates).
- 10- Bids will be opened in the office of the General Manager, Construction Circle (Ganga), Uttarakhand Peyjal Nigam, Haridwar, Uttarakhand by the designated Tender Opening Committee in the presence of intending bidders or their authorized

representatives on the date and time as mentioned in tender time schedule (Key Dates).

- 11- The bids shall remain valid for a period not less than 90 days from the date of bid opening.
- 12- Bidders are advised to visit the respective sites before quoting their rates. Once the bids are accepted, no claim whatsoever will be acceptable.
- 13- During the construction work, the bidder shall give preference to local labour and shall follow the labour laws of Central / State Government.


