- 1 Sealed Quotations are invited. Name of Work & Date of opening of Quotation etc. should be clearly written on the Sealed Envelope. Earnest money should be submitted in separate envelope. Quotation in unsealed envelope shall not be entertained.
- 2 No quotation without Earnest Money shall be accepted.
- 3 Quotations received in due time at our designated offices will only be entertained. Department will not be responsible for any postal delay etc.
- 4 Conditional quotations will not be accepted. Any wrong facts or information if provided by any consultant/firm to departmental than his quotation will be rejected.
- 5 All rights to cancel any or all the quotations without mentioning any reason, are reserved in the undersigned authority.
- 6 Mode of Payment:
 - a 20% of Cost of total amount shall be paid after approval of technical proposals from competent authority.
 - b 30% of cost of bid amount shall be paid after submission of D.P.R. (Upto 50% of total amount).
 - c 20% of bid amount shall be paid after the approval of D.P.R. from competent authority (Upto 70% of total amount).
 - d Remaining 30% of bid amount shall be paid after the approval of D.P.R. from SLTC & SHPSC Govt Of Uttarakhand (Complete 100% of total amount).
 - e The final cost of work (General Abstract of Cost) without centage shall be considered as, approved by the competent authority of Government of Uttarakhand. Accordingly, the necessary adjustments shall be made in the final bill.
- 7 The rates quoted by the firm stand fixed. The firm will not be paid any extra payment for any decrease or increase in population.
- 8 Any further enquiry about scope of work etc. can be obtained from office during office hours of any working days.
- 9 In Preparation of the D.P.R. guidelines of AMRUT programme of MoUD Govt. of India shall be followed.
- 10 The bidders are advised to visit the site physically to assess the scope of work/site conditions
- 11 D.P.R. has to be prepared along with necessary form and formats of AMRUT programme Consultant will be responsible and have to engage for required approval of DPR from Nagar Nigam/Urban development directorate, SLTC & SHPSC of Govt. of Uttarakhand etc.
- 12 All rates shall be inclusive of all taxes and levies payable.
- 13 The Consultant/Firm has to comply all local rules, laws and act of the land.
- 14 All statutory deduction will be made by the Uttarakhand Peyjal Nigam from the Consultant/Firm.
- 15 Settlement of dispute in arbitration, except where otherwise provided, all the dispute relating to meaning of scope of work methodology etc. will be settled as per arbitration act.
- 16 Detail Information about Site shall be provided by the concerned A.E./A.A.E./J.E. before the Survey.
- 17 Earnest Money must be pledged in the name of Executive Engineer, Construction Division, Uttarakhand Pey Jal Nigam, Haldwani in the form of N.S.C./F.D.R. of any Nationalized Bank. Rs. 100.00 denomination Non Judicial Stamp Paper with Rs 1.00 revenue ticket affixed on it duly signed to be along with Quotation mentioning for validity.

- 18 All necessary modification as many times as required from departmental authorities SLTC & SHPSC of Uttarakhand Govt. etc up to the final sanction of D.P.R. from Govt. of Uttarakhand will have to be done by the Consultant/Firm in the time limits specified by the departmental authorities for this no extra amount will be payable to Consultant/Firm.
- 19 The above work is in the AMRUT programme of G.O.I. Therefore time limits to prepare the D.P.R. have to be followed under all situation/circumstances and the complete D.P.R. is to be prepared in the specified time limit of 3 Months otherwise in case of delay (Except for the reason beyond the control of the Consultant/Firm). Penalty @ 10% of DPR preparation cost per month will be deducted from the Bill of Consultant/Firm.
- 20 Presentation/EFC Presentation of D.P.R. and accordingly required necessary modification up to the Final Sanction of the D.P.R. from Govt. of Uttarakhand will have to be done by the Consultant/Firm. For which no extra charge will be payable to Consultant/Firm.
- 21 Consultant have to start submission of D.P.R. of some Sewerage zones (As directed by the engineer in charge) in one month time after inception of work and must ensure submission of D.P.R. of all zones (whole city) in specified time limit of 4 months.
