On behalf of the Chairman, Uttarakhand Peyjal Nigam (Uttarakhand Peyjal Sansadhan Vikas Evam Nirman Nigam), Dehradun sealed tenders in **Two Bid System**, on item rate contract basis (inclusive of all material), are invited for the construction of following works of Gwaldam G.O.V. Pumping water supply scheme of block Tharali in District Chamoli (Uttarakhand) from technically and financially capable bidders up to prescribed time & date and on the portal as mentioned in terms and conditions given below:-

Terms and Conditions:-

- 1-** Bidders are required to make an offline payment for the cost of bidding document. The requisite fee shall be paid by demand draft in favour of the Executive Engineer, Construction Division, Uttarakhand Peyjal Nigam, Karanparyag payable at Karanparyag. Online bids must be accompanied by the electronic scanned copy of the demand draft for the amount as mentioned in the table above for the corresponding contract package. This demand draft in original shall be submitted either by registered post or by hand in the office of Executive Engineer, Construction Division, Uttarakhand Peyjal Nigam, Karanparyag on or before the date mentioned in the tender time schedule (Key Dates). Failing to do so, the bids will be declared non-responsive.
- 2-** Bid Security (Earnest Money) shall be in the form of FDR / CDR or NSC issued by any Public Sector (SBI & Nationalized) / Scheduled Banks or Indian Post Offices respectively, with maturity date at least up to 45 days beyond 4 months' validity period of the Bid, pledged in favour of Executive Engineer, Construction Division, Uttarakhand Peyjal Nigam.

Karanparyag. Online bids, to be conforming, must be accompanied by the electronic scanned copy of bid security for the amount as mentioned in the table above for the corresponding contract package. The original copy of bid security shall be submitted either by registered post or by hand in the office of Executive Engineer, Construction Division, Uttarakhand Peyjal Nigam, Karanparyag on or before the date mentioned in the tender time schedule (Key Dates). Failing to do so, the bids will be declared non-responsive.

3- Bid Submission procedure :-

- a. The bid documents shall be published online on the e-Government Procurement System (e-GPS) portal i.e. <http://www.uktenders.gov.in> on the date and time as mentioned in the tender time schedule (Key Dates).
 - b. All the interested bidders are required to register on e-GPS portal i.e. <http://www.uktenders.gov.in> which is free of cost.
 - c. The bidder is also required to obtain Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Digital signature is mandatory to participate in the e-tendering. More information on how to obtain a DSC and also its use is available under the link "Information about DSC" on the e-GPS portal i.e. <http://www.uktenders.gov.in>. Bidders already possessing the digital signature issued from authorized CAs can use the same in these tenders.
 - d. Bids shall be submitted online on the same e-GPS portal i.e. <http://www.uktenders.gov.in> after signing them electronically using a Digital Signature Certificate (DSC) within the stipulated time as mentioned in tender time schedule (Key Dates). Online bids, ready for submission / upload, shall include bidding document, scanned copy of Cost of bidding document, Bid Security & all the Supporting Documents in support of qualification other than rates filled by the bidder in BOQ.
- 4- Offline submission of Original Documents :- In addition to the cost of bidding document and bid security as prescribed in Sl. No. 1 & 2 above, the bidders are also required to submit in original all the documents listed in Sub Clause 4.2 of Section-III I.T.B., either by registered post or by hand, in the office of Executive Engineer, Construction Division, Uttarakhand Peyjal Nigam, Karanparyag upto the date and time as mentioned in tender time schedule (Key Dates).
- 5- Bids will be opened in the H.Q. Uttarakhand Peyjal Nigam, Dehradun by the designated Tender Opening Committee in the presence of intending bidders or their authorized representatives on the date and time as mentioned in tender time schedule (Key Dates).
- 6- The bids shall remain valid for a period not less than 180 days from deadline date of bid submission.
- 7- Bidders are advised to visit the respective sites before quoting their rates. Once the bids are accepted, no claim whatsoever will be acceptable.
- 8- During the construction work, the bidder shall give preference to local labour and shall follow the labour laws of Uttarakhand State.
- 9- A pre bid meeting to clarify the issues regarding the tenders is proposed to be held in the Office of The Executive Engineer, Construction Division, Uttarakhand Peyjal Nigam, Karanprayag (Chamoli) on date & time as stipulated in tender time schedule (Key Dates).
