- 2- The bid validity period shall be 4 months after the bid submission deadline date.
- 3- Bid shall be submitted online (e-tender) on the e-GPS portal <http://www.uktenders.gov.in>
- 4- Bidder/Contractor shall visit the site before submitting tender.

Bid Submission Procedure :-

Bidders must be registered on the (e-GPS) portal <http://www.uktenders.gov.in>.

In Order to be able to the e-GPS, a bidder needs to set up their machine (computer), the bidder has to install same utilities (free software) as per instruction given in Help Manual for machine (Computer) setup' which is available for the the download on the e-GPS portal

The bid submitted shall be signed electronically with a Digital Signature Certificate to establish the identity of the bidder bidding online. These digital signature certificates are issued by approved certifying authorities, authorized, authorized by the controller of certifying Authorities, Government of India. - D. Bidders are required to make an offline payment for the cost of bidding document. Online bids must be accompanied by the electronic scanned copy of the demand draft of the amount as mentioned in the table above in favour of "Project Manager, Construction Unit, Uttarakhand Peyjal Nigam, Rishikesh, Dehradun, Uttarakhand".
- E. The Original copy of demand draft of the fee of the bidding document must be submitted to the Project Manager, Construction Unit, Uttarakhand Peyjal Nigam, Rishikesh on or before the date mentioned in the tender schedule (key dates).
- F. Earnest Money shall be in the form of F.D.R./C.D.R. of any Nationalized Bank/Schedule bank/Indian Post Office Pass Book or National Saving Certificate pledged in favour of Project Manager, Construction Unit, Uttarakhand Peyjal Nigam, Rishikesh (to be valid for at least 180 days). Tenders received without the requisite EMD shall be rejected.
- G. Bids, to be a conforming Bid, must be accompanied by the electronic scanned copy of the bid security for the amount as mentioned in the table above for the contract package. The original copy of the Bid Security must be submitted to the Project Manager, Construction Unit, Uttarakhand Peyjal Nigam, Rishikesh or before the date mentioned in the tender schedule (key dates)
- H. Submission of Bid online: Bidder have to submit and sign their encrypted Bids (by their user public – key) online using their digital signature certificate within the date and time as started in the tender schedule (Key Dates). The electronic Bid of only the Bidders who have submitted their Bid within the stipulated time, as per tender time schedule (Key Dates), will be accepted by the system.
- I. Bid shall be opened by the prescribed committee at the Office of Chief General Manager, Construction Wing, Uttarakhand Peyjal Nigam, 403/1, Indira Nagar, Dehradun.
- J. All order relevant rules and conditions of tender process can be seen from the ITB in bidding document.
- K. Income Tax, Trade Tax and all other taxes/CESS shall be deducted from each bill of the contractor as per prevailing Government Rules.
- L. The Competent authority of the department reserves the right to change the schedule of the tender and to cancel the invited tender and the issuance of the tenders.
- M. The competent authority of the department reserves the right to cancel any or all the tenders without assigning any reason.

7- Technical Specification and Requirement:-

- I. The bidder shall fulfill the qualifying criteria mentioned below and in the bid document, of their own & they shall submit the relevant document online to support their eligibility. The copies of these documents shall be signed and stamped by the bidder and submitted while physical submission: -
- II. The average annual turn-over for last 3 year shall be at least Rs. 4.00 croreduly certified by a Chartered Accountant, shall be submitted in support of the requisite financial Turn-over.
- III. The intending bidder shall be specialist in the construction of Auditorium or similar works. All such bidders shall have to fulfill the criteria of satisfactory execution and completion of works as given below:-
 - (a) 3 similar work each of value not less than 40% of the estimated cost put to the tender.
 - (b) 2 similar work each of value not less than 60% of the estimated cost put to the tender.
 - (c) One similar work of value not less than 70% of the estimated cost put to tender, all amounts shall be rounded off to a convenient full figure.The above criteria will hold good for electrical/mechanical works as given in BOQ/ Schedule "G".
- IV. Copy of Sales TAX/VAT/TAN/PAN and Registration Certificate/Excise Registration.
- V. The bidder should provide certificate on a Non-Judicial Stamp Paper of Rs. 10.00 that none of his/her relative working with Office of the General Manager, Construction Wing, Uttarakhand Peyjal Sansadhan Vikas Nirman Nigam, Dehradun and in the office of Project Manager.

VI. Credit limit of bidder should be at least Rs. 5.00 crore towards his credential from any Nationalized Bank.

Peyjal Nigam reserves the right to accept/reject any or all the tenders in part of full or divide the work among two or more parties without assigning any reason whatsoever and in such case bidder/intending bidder, shall not have any claim on peyjal Nigam.
