7. The Prebid meeting will be held on **30.05.2017 at 15:00 Hrs**, in Head Quarter Uttarakhand Peyjal Nigam at Dehradun.
8. **Financial Bid** duly filled as per **Annexure 'A'** giving the rates for quoted items in "**BOQ**" format separately on website www.ukTenders.gov.in by the Tenderer. **It should not be disclosed in Technical Bid.**
9. In case, the date of opening of e-EOI is declared a public holiday, the e-EOI shall be opened on the next working day.
10. The e-EOI document should be signed only by a person to whom the power is delegated by the competent authority and who is authorized in the name and on behalf of company/firm to do so and become a party.
11. The advance will be paid to Consultancy / Training agency only on the submission of valid bank guarantee in the prescribed format to Nigam with prescribed validity period.
12. Bid shall be valid for acceptance for a period of **90 days** from the date of opening of financial bids.
