Terms and Conditions:-

- 1- Quotations should enclosed an earnest money of Rs 10000.00 in the form of NSC of post office or FDR form nationalize / Schedule bank. Which should be pledged in the name of Executive Engineer, World Bank Project Unit, Dehradun.
- 2- The deliverables should include following works.
 - a. Development of android app and multiple user plat form for baseline data collection work as per the data points given by the department.
 - b. Development of Dashboard for real time monitoring of ongoing survey work.
 - c. Training to the surveyors of survey agency for complete understanding of the system.
 - d. Android Application and dashboard should incorporate data safety and security with 128-bit encryption as per ISO 27001: 2013. The Application & dashboard must be compatible and compliant with data center for data storage by NIC servers.
 - e. Supervision, monitoring & evaluation of survey work by developing an admin panel which can monitor all the survey going on in multiple locations across state for 3 months.
 - f. The App must be suitable for offline implementation of app to be used in any remote location having no mobile network.
 - g. Full project implementation and support for three months from the date of start of survey work in the field for household baseline data collection survey. Which will be notified by the department. The time period for the backend support may be extended as per requirement of work.
 - h. Extension of term may be considered after due approval for a monthly fixed sum.
 - i. Any discrepancy found in the App. has to be resolved/ updated within 3 days.
 - j. (i). Workable prototype of the platform must be submitted to the department within 10 days from signing of agreement.

- (iii). Final version of prototype of the platform duly tested and installed on the system should be submitted to the department with in 28 days from the signing of agreement.
- 3- (i). 25% of the payment for item "01" shall be released after submission of workable prototype of application.
(ii). 15% payment for item "01" shall be released after final submission and testing of application, dashboard and approved by the department and training to the surveyors.
(iii). 15% payment for item "01" shall be released after 1 month of implementation and support.
