The queries should reach the Office of The Executive Engineer, Project Implementation Unit (AMRUT), Uttarakhand Peyjal Nigam, Haldwani (e-mail at piuhaldwani@gmail.com) two days prior to the meeting. Contractor or his authorized representative only can take part in this meeting.
4. The bid document shall be published online on the e-government procurement system (e-GPS) portal <http://www.uktenders.gov.in>. All interested bidders must be registered on

5. The bid validity period shall be **180 days** after the bid submission deadline date.
6. Bid shall be submitted online (e-tender) on the e-GPS Portal <http://www.uktenders.gov.in>.
7. Bidder/Contractor should visit the site before submitting the tender.

9. Tender inviting authority reserves right to cancel the bid without assigning any reason.
10. Joint venture is allowed for the above work.
11. It will be responsibility of bidder to upload all the required documents correctly on the website. If quoted rates of any bidder do not reflect in the system generated comparative statement due to any reason such as tempering of BOQ template, modification of BOQ template what so ever, such bid will be treated as tempered and will not be considered.
12. The Tenderer must be familiar to the topography & terrain of the town for, which intending bidders are strictly advised to visit the site of works, preferably before pre-bid meeting.
13. In case of a holiday falling on the date of opening of tender, the tenders will be opened on the very next working day.
14. Tenders are invited on two bid system. 1- Technical 2-Financial bids. Only successful bidders who qualify as per eligibility criteria shall only be considered.
15. Amendments to this tender notice/tender document, whatsoever, will only be published on e-GPS portal <http://www.uktenders.gov.in> bidders are advised to check the above website regularly.
16. The bidders must be registered with Central / any State Government / Central or any State Government undertaking department / Government institutions in adequate category.
17. **Bid Submission Procedures :-**
 - a) Bidders must be registered on the (e-GPS) portal <http://www.uktenders.gov.in>.
 - b) In order to access the e-GPS, a bidder needs to set up their machine (Computer), the bidder has to install same utilities (Free software) as per the instruction given in help manual for machine (computer) setup which is available for download on the e-GPS portal.
 - c) The bid submitted shall be signed electronically with a Digital Signature Certificate (DSC) to establish the identity of the bidder, bidding online. These DSCs are issued by approved certifying authorities, authorized by the controller of certifying authorities, Government of India.  - d) Bidders are required to make on offline payment for the cost of bidding document.
