Assignment: Title: Empanelment of Design Build and Operate Contractors/ Firms for 26 water supply systems in peri urban areas.

The Government of Uttarakhand, Department of Drinking Water & Sanitation has applied for IBRD Loan no. 8805-IN from the World Bank for financing of Uttarakhand Water Supply Program (UWSP) for Peri Urban Areas.

Government of Uttarakhand Intended for Empanelment of Build and Operate Contractors for development of 26 water supply schemes in various Census towns of Uttarakhand.

Expression of Interest is invited from eligible firms/ Contractors to indicate their interest in providing the above services. Interested firms/ Contractors must provide information indicating that they are qualified and relevant experience to perform the services (brochures, description of similar assignments, experience in similar works, availability of appropriate skilled etc). The short-listing criteria are:

- (i) Age of the *firm/ Company* should not be less than three years;
- (ii) Firm/ Contractor has Completed construction of water supply/ Sewerage system and Performance based operation and maintenance for at least 18 Months on Build and Operate mode *for any State Government/Central Government* in the last five financial years, duly supported by copy of agreement with ToR & completion certificate of such assignments issued from competent authority.
- (iii) Average annual turnover in last three financial year should not be less than 80% of cost of Scheme/ Schemes. Contractors/ Firms/ Company may associate with other firms/ contractor in the form of a joint venture/consortium to enhance their qualifications (Joint Venture must not have more than three partners).

Contractor/ JV/Firm/ consortium may submit their interest in providing service for one or more census town jointly or separately.

A Contractors/ Firms / Company will be empanelled in accordance with the above criteria.

#### 1. BACKGROUND

#### **Country Context**

**1.1 India's urban population has grown from 28 percent in 2001 to 32 percent in 2011,** and for the first time, absolute increase in urban areas is higher than rural areas. Although the proportion of urban population concentrated in larger cities continues to remain high, several rural areas are transitioning towards urban characteristics or being absorbed into the limits of urban local bodies. Many rural areas in India which have attained significant urban characteristics continue to administratively be under the control of rural local bodies. These transitional areas, generally classified as peri-urban areas, have significant backward and forward economic linkages with urban as well as rural areas and present a unique governance, regulatory, infrastructure, service delivery and environmental challenge for policy makers. Being in a transitional state, they also face unique infrastructure and service delivery challenges including water supply and sanitation provision.

#### State Context

1.2 Uttarakhand, like the rest of India is rapidly urbanizing. As per Census 2011, the population of the State was 10.11 million with decadal growth rate of 25.2% (all India 17.6%) and population density of 189 persons/km<sup>2</sup>. It is one of the most rapidly urbanizing state of India with urban population growth at 42% during 2001-2011, substantially higher than the national average growth of 32% during the same period. Emergence of peri-urban regions is a clear and growing phenomenon in Uttarakhand. The state has witnessed significant rise in peri-urban areas. The increase in Census Towns (CTs) in Uttarakhand from 12 in 2001 to 41 in 2011 is also an indicator of growth of peri-urban areas in the state. The 41 CTs collectively account for around 4.9 lakhs (2011) which is approximately 17% of the state's urban population. A large number of these census towns have emerged in select growth corridors and adjacent to major urban areas of Uttarakhand (mostly Municipal Corporations). In terms of concentrations, four distinct clusters emerge: i) Dehradun-Rishikesh (National Highway (NH) 72), ii) Hardwar-Roorkee (NH 58) iii) Haldwani-Rudrapur (NH 87) and (iv) Khatima region along NH-125.

#### Sector Context

**1.3** Improving access to Water Supply and Sanitation (WSS) services is a development priority for the Government of India (GoI) and Government of Uttarakhand (GoUK) and significant investments have been made in the sector across urban and rural areas. The Government of Uttarakhand undertakes a number of WSS programs including the GoI flagship programs besides undertaking state/district plan schemes and externally aided projects. The water supply service delivery in the state, however still falls short of the GoI target for water supply for rural areas (NRDWP), urban areas (MoUD benchmarks). However, the state has achieved Open Defecation Free (ODF) status in June 2017.

#### Strategic Vision

1.4 The Government of India envisages that all the states will achieve universal coverage for water and sanitation services. The Government of Uttarakhand has a vision to achieve universal water supply coverage in urban areas by 2030. The Government of India aims to achieve the same in rural areas by 2022 The GoUK also aims for integrated development of the urban areas by making the cities vibrant, clean, and infrastructurally strong, along with improvements in service delivery. The Government of India has a vision to achieve universal sanitation coverage in urban and rural areas by 2019 and the State Government's vision is aligned to the national targets. Thus the objectives of GoUK are aligned with GoI programs that target universal WSS service delivery coverage across the country.

**1.5** While the state has made reasonable improvements in the water supply and sanitation sector, including the support from World Bank RWSS programs, a number of challenges have to be addressed with respect to water supply particularly in view of the emergence of large number of peri-urban areas in the State. The state has a long way to go in terms of universal coverage and service levels in both urban and rural water supply. The issue of water supply service delivery is further exacerbated in peri-urban areas, which are yet to be integrated in the planning process. The Urban and Regional Development Plans Formulation and Implementation Guidelines (URDPFI) of the Ministry of Urban Development (MoUD), Government of India, provides guidance for planning of peri-urban areas. It recommends provision of WSS services at par with urban standards. However, the programs of the Ministry of Urban Development do not include peri-urban areas. The programs in the rural sector that cover the peri-urban areas (as they are administratively rural), only provide for service levels at par with rural areas, while their aspirations have been urban. Traditionally, State programs have followed GoI approach and therefore, they have not provided urban like services in rural areas. Water supply programs in peri-urban areas plan for lower service levels (e.g. 70 lpcd supply applicable to rural areas as against 135 lpcd for urban areas) as well as small scale interventions (small tube well schemes). Therefore, it has become imperative for the GoUK to address the service delivery issues in these peri-urban areas, which have largely been neglected in the planning process, with most consumers adopting 'self-provisioning' coping mechanisms. The water supply interventions to improve services in the urban outgrowths is an urgent priority.

### GoUK partnership with the World Bank

- 1.6 GoUK has been successful in introducing innovative approaches to WSS challenges in the past. The state has successfully implemented two Rural Water Supply and Sanitation (RWSS) Projects supported by The World Bank (i) the Swajal Project (1996-2003) which piloted the demand responsive, community based schemes; and (ii) the Uttarakhand Rural Water Supply and Sanitation Project (URWSSP 2006-2015) which adopted a Sector Wide Approach (SWAp) for decentralizing service delivery responsibilities to the Panchayati Raj Institutions (PRIs). Thus the GoUK has been successful in implementing innovating approaches to deliver WSS services.
- 1.7 The World Bank has approved in principle its support of \$120 million to the Uttarakhand Water Supply Program for Peri-urban Areas (UWSP) out of a total Program amount of US\$150 million. The World Bank's financed program is titled Uttarakhand Water Supply Program for Peri-urban Areas (UWSP). A new financing instrument Program for Results (PforR) will be used by the World Bank for this Program, wherein funds under the Program will be disbursed from the World Bank to GoUK based on achievement of pre-agreed results in policy reforms, institutional improvements of sector agencies and improvement in water supply services in peri-urban areas of the State.

#### Program Areas

- **1.8** Building on the definition of Census Towns (CTs), the targeted peri-urban areas for the GoUK for this program are those which meet the criteria of (a) density as minimum 200 persons/sq.km, (b) within 10 km aerial distance from the existing limits of ULBs, and (c) not upgraded/merged into Statutory Town. The identified 35 peri-urban areas include 31 CTs and 4 CT like areas that are rapidly expanding in the four Growth Clusters: Growth Cluster I: Dehradun-Rishikesh, Growth Cluster II: Haldwani-Kathgodam, Growth Cluster III: Hardwar-Roorkee, Growth Cluster IV: Khatima, and some stand-alone CTs.
- **1.9** The present population- 2017 of these 35 CTs is 769,088 and number of households is 147, 492, based on baseline survey conducted by UJS and UJN. About 45 percent households in these CTs have water connections. Under each of these towns/habitations, priority will be accorded to the towns with lower service levels. The GoUK's water supply program for peri-urban areas specifically targets improvements

from the existing low coverage, poor services and intermittent supply as per rural standards, to the provision of universal water supply at par with urban standards. The GoUK would like to achieve universal metered house hold connections with good quality, pressurized, up to 135 lpcd supplied 24x7 in the rapidly expanding peri-urban areas (though the target for the Program is at least 16 hours of water supply). The investment requirement is USD 150 million for the medium-term program (2018-23). The funds will be used primarily for construction for water supply assets, new or rehabilitation of networks, and argumentation of water source, treatment, storage, disinfection, and distribution through piped networks that are metered at the household level to achieve urban service levels. Funds will also be used for strengthening monitoring, policy and planning outcomes of GoUK's water supply program for periurban areas along with the support activities including program support/management, studies, capacity building etc. The GoUK, through a GO, has recently announced the water supply program for peri-urban areas as a priority program.

1.10 The table 2 below illustrates the areas that have been identified by the GoUK for interventions under the Program. World Bank Financing of USD 120 million will directly fund a population of 5,16,222 and linked to the achievement of DLIs. The selection of the peri-urban areas will be based on the feasibility of the water supply schemes and keeping in view the best outcomes of the program.

1.12 The **35 peri-urban areas** of Uttarakhand, have an estimated population of 0.77 million (7.69 lakhs, in 2018) covering 1,47,500 households. Around 45 percent (65,650) of the households in these periurban areas have House Service Connections (HSCs) and receive water supply within their premises. However in Khatima region, Haridwar-Roorkee and Khatima region growth corridor, only 14 percent of the households have HSCs and many of the households have hand pumps (or use public stand posts) as the source of drinking water. The total amount of water produced in these areas is around 40 mld and the average water supply across the prioritized peri-urban areas is around 63 lpcd (this is water produced and may not reflect the amount of water supplied at the consumer end taking into consideration UfW). While there is no formal assessment undertaken on the NRW, it is estimated to be around 40%. Thus the supply at the consumer end is estimated to be between 30-40 lpcd. On an average, the duration of water supply is around 3 hours in these peri-urban areas. However, there are variations within the growth corridors. The residual terminal pressure is less than 3 meters. None of these growth clusters report any quality issues and none have metering of household connections. The average monthly tariff is around INR 150 based on flat charges (contingent on the pipe diameter and number of taps in the house) and the

collection efficiency is around 90%. It is estimated that the current O&M cost recovery is at around 40%. Ground water is the main source of water supply in the peri-urban areas (90%) and thus involve pumping through tube wells/hand pumps as the main means of water supply. There are very few peri-urban areas that operate surface water based schemes either through pumping or gravity (10%). Surface water based schemes are used in Khatiyari. The source of water, ground water, is sustainable and sufficient to cater to the needs of the peri-urban areas in the future. The following table summarizes the existing situation in the 35 peri-urban areas as against select MoUD service level benchmarks:

- **1.13** The Govt. of UK Department of Drinking Water and Sanitation has applied for IBRD loan no. 8805- IN from World Bank from financing of Uttarakhand Water Supply Program (UWSP) for Peri Urban Areas. The World Bank has approved its support of \$120 Million.

- **1.15** The outcomes will be monitored as per the service level benchmarks (SLBs) recommended by the MoUD, GoI:
  - Coverage of Water Supply connections 100%
  - Per Capita Supply of Water up to 135 lpcd
  - Extent of Non-revenue Water Maximum 30% (SLB is however 20 percent)
  - Extent of Metering 100%
  - Continuity of Water supplied –minimum 16 hours (SLB is however 24 hours)
  - Efficiency in redressal of customer complaints 80%
  - Quality of Water Supplied -up to 100%
  - Cost Recovery 100% (operations costs)
  - Efficiency in Collection of Water Charges 90%
  - Terminal pressure of 12 m during peak supply period (not included in the present SLBs of MoUD).
- **1.16** The Program interventions will support improvements in efficiency and sustainability of water supply services through metering, volumetric tariffs, NRW reduction, and improving O&M cost recovery. Following are the key features for service delivery improvements:
  - A minimum 16-hour water supply meeting GoI water quality standards, supplied at a minimum pressure of 12m, for no less than 300 days in a year.
  - 100% customer metering and volumetric tariffs.
  - Sustainable water supply systems, which recover O&M costs through user charges with transparent GoUK subsidies, if any.
  - Appropriate service delivery models, including PPP options, for accountable services.
- 1.17 The Authority intends to select, through an open and transparent tender process, one or more private sector partner ("Contractor") for each of Census Town as set out in Clause 1.13 above. Broadly, the Contractor shall provide the following services ("Project") in a Project Areas as set out in clause 1.14 & 1.15 above
  - (a) Construction of new multi census town or single census town water supply schemes predetermined by the Authority;
  - (b) Construction of extensions to existing water supply schemes pre-determined by the Authority; and
  - (c) Manning, operations, maintenance and tariff collection of the water supply schemes constructed as per (a) and (b) above for a period of five years after commissioning of such assets.
- **1.18** The Contractor shall incorporate under the Companies Act, 2013 for execution of the Project.

- 1.19 The Authority invites Applications, through this common EOI document, for pre-qualification of interested parties ("Applicant(s)") who fulfill the pre-qualification criteria as set out in section 2 and are interested in participating in one or more Projects. No Applicant shall submit more than 1 (one) Application to express interest in one or more Projects. For the avoidance of doubt, in the event, an Applicant submit its Application as a member of a consortium or an unincorporated partnership, such Applicant cannot be a member of a consortium or unincorporated partnership in any other Application. Except and otherwise the member is a expert of any specialized job.
- **1.20** The Contractor shall be responsible for engineering, procurement, construction, operation and maintenance of its Project in accordance with the provisions of a contract agreement ("**Contract Agreement**") to be entered into between the Authority and the Contractor. The total duration of the Project shall be for a period of at least 8 (Eight) years ("**Contract Period**"). The construction of all identified works under the Project shall be completed within a period of 3 (three) years from the date of signing of the Contract Agreement (including 6 (six) month of trial & testing) and operate and maintenance of assets, after completion of construction, for the remaining duration of the Project in accordance with the provisions of the Contract Agreement.
- **1.21** The Authority intends to make the following payments to the Contractor, in accordance with the provisions of the Contract Agreement, for its services:
  - (a) 10% mobilization advance will be given to the contractor against security. Which will be recovered from running bills.
  - (b) Payment up to 70% of the capital cost of contract agreement of the Project paid over the construction period based on achievement of construction milestones.
  - (c) Equated balance payments during the operation and maintenance period in 3 (three) years to cover the remaining estimated capital cost of the Project .
  - (d) The cost of manning, operations, tariff collection and maintenance (**"O&M Costs**") of the water supply schemes constructed. The O&M Costs shall be paid at a pre-determined rate.

For the avoidance of doubt, the Contractor shall not be entitled to any other source of revenue including levy of user tariffs. It may be noted that the payment scheme proposed above is preliminary and is subject to change by the Authority.

#### 2. **PRE-QUALIFICATION CRITERIA**

- **2.1** To be eligible for pre-qualification, an Applicant shall fulfill the Technical Capacity and the Financial Capacity individually or jointly, as indicated below:
  - (A) **Technical Capacity**: For demonstrating technical capacity and experience ("**Technical Capacity**"), the Applicant shall, over the past 3 (three) financial years (i.e. FY 2017-18, FY 2016-17 and FY 2015-16), have:
  - paid for development of, or received payments for construction of one completed civil engineering construction project in Category 1 having an Adjusted Construction Cost, as defined in Clause 2.2, of at least 80% of the proposed contract value of Census Town/ Towns (if contractor submit bid for more than 1 town); and
  - (ii) paid for development of, or received payments for construction of completed civil engineering construction projects during the past 3 (three) financial years in Category 1 having a cumulative Adjusted Construction Cost, as defined in Clause 2.2, of at least 300perscent of the proposed contract value of census town/ towns.
  - (iii) Contractor has experience for performance based operation & maintenance of water supply scheme for at least 18 months of 40 % of the proposed contract value of Census Town/ Towns (if contractor submit bid for more than 1 town)
  - (B) **Financial Capacity:** The Applicant shall have:
  - (i) A net worth of at least 100% of the proposed contract value of Census Town/ Towns (if contractor submit bid for more than 1 town) as on March 31, 2017; and
  - (ii) An average annual revenue of at least 100% of the proposed contract value of Census Town/ Towns (if contractor submit bid for more than 1 town)over the past five financial years.

For the purposes of this EOI, net worth ("**Net Worth**") shall mean the sum of subscribed and paid up equity and reserves from which shall be deducted the sum of revaluation reserves, miscellaneous expenditure not written off and reserves not available for distribution to equity shareholders.

(C) **Bid Capacity**: Applicant shall have bid capacity for construction work is equal to or more than the total bid value of the work. The available bid capacity will be calculated as under:

Assessed Available bid capacity = (A\*N\*1.5-B)

Where,

A = Maximum value of civil engineering works executed in any one year during the last five years (updated to the price level of the financial year ..... at the rate of 5% per year), taking into account the completed as works in progress).

N = Number of years prescribed for completion of the works for which bids are invited (period up to 6 months to be taken as half-year and more than 6 months as one year).

B = Value, at the current price level, of existing commitments on on-going works to be completed during the period of completion of the works for which bids are invited.

# **Note**: The statements in Section IV showing the value of existing commitments of on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer in charge, not below the rank of an Executive Engineer or equivalent.

**2.2** The Adjusted Construction Cost ("**Adjusted Construction Cost**") of an eligible project shall be determined as the product of the construction cost of the project, and the adjustment factor based on the category of the project, as specified in Table below.

- **2.3** The entity, whether a single entity or a member of a consortium, joint venture or an unincorporated partnership, which is claiming any experience under Technical Capacity, should have:
- (i) in case claiming development experience of a project: held, in the company owning the project, a minimum of 26% (twenty-six per cent) equity and should have been designated as the lead member for such project, from the date of signing of the concession agreement till date of commercial operations of the project for which experience is being claimed;
- (ii) in case claiming construction experience of a project: held more than 50% (fifty percent) of the paid up and subscribed share capital of the company constructing the project.
- **2.4** Experience for any project or activity shall not be claimed by: i) two or more members of a consortium or an unincorporated partnership; or ii) two or more Applicants. In other words, no double counting by a consortium, an unincorporated partnership or Applicants in respect of the same experience shall be permitted in any manner whatsoever.

#### 3. INSTRUCTION TO APPLICANTS

- 3.1 The Applicant shall provide all the informations sought under this EOI and otherwise sought. The Authority will evaluate only those Application that are received in the required formats and complete in all respects.

Notwithstanding anything contained in this EOI, in the next stage of this tender process, pre-qualified Applicants shall be expected to meet both Technical Capacity **and** Financial Capacity. The pre-qualified Applicants, who do not expect to meet both criteria on their own, may form suitable consortium for this purpose, in the next stage of this tender process, in accordance with the provisions of the RfQ and / or RfP.
